Valley Charter High School (VCHS), with small classes and personalized attention, is a FREE PUBLIC high school accredited by the Western Association of Schools and Colleges (WASC) and is a Certified California Charter School. VCHS has the third highest 2008 API score (766) and the highest 10th grade passing rate (90%) of all high schools in Stanislaus County. As part of the Bill and Melinda Gates Foundation Early College High School Initiative, our students take classes at Modesto Junior College and MJC units count as credit for our high school graduation.

The facility includes eight classrooms, two computer labs, and a large multi-purpose room. The facility is maintained and cleaned daily by our custodian. There are security cameras that monitor the exterior of the building. Our staff monitors our school facility, including school grounds, 15 minutes before the start of school, during nutrition and lunch breaks, and immediately after school. We have a closed campus, and all visitors must register with the office upon arriving on school grounds. We regularly review our school safety plan, which pays particular attention to lockdown and fire drills.
